beginning at a point on the dividing line of the Township of Croyle
and a public street in the borough of South Fork, near the Hotel of
James Dailey, in said borough, and ending at a point near the public
road of said township, which said viewers have been appointed by the
said court.

Now the condition of this obligation is such, that if the said boundens
shall pay, whatever costs incurred in the laying out the said road, as may
be imposed or directed to be paid by the said court, at the termination
of the said proceedings.
