REPORT OF THE SUPERVISORS OF CROYLE TOWNSHIP

The petition of MIKE KISHLOCK, OLIVER W. PLUMMER, and
JOSEPH HUBER, respectfully represents:

- (1) That they are the Road Supervisors of the Township of
Croyle, Cambria County, Pennsylvania.
- (2) That they propose to open a public road in Croyle Township
as shown on the blueprint attached hereto and made a part hereof. Said road
shall have a width of forty (40) feet and a length of nine hundred six (906) feet
and shall abut on property owned by certain residents of Croyle Township as
set forth on the said draft attached hereto.
- (3) That your petitioners have given ten (10) days' notice to the
property owners affected by the laying out of the said road as required by the
Act of Assembly of a hearing, and after said hearing your Supervisors deem
that said road is necessary for the public convenience.
- (4) Attached hereto and made a part hereof are releases
executed by the owners of property abutting on said proposed road.

WHEREFORE your petitioners pray that this report and the exhibits attached hereto may be filed in the Office of the Clerk of Courts of Quarter Sessions of Cambria County, Pennsylvania.

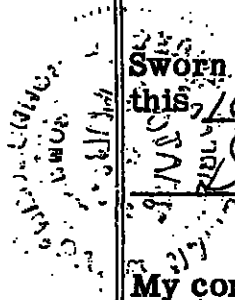
