


TO THE HONORABLE THE JUDGES OF THE COURT OF QUARTER SESSIONS OF CAMBRIA COUNTY.



The Petition of the Commissioners of Cambria County respectfully represents:

That the County Bridge over the Blacklick Creek in the Borough of Vintondale in said County of Cambria had fallen into the stream and the building of a new bridge made necessary, and that your Petitioners procured an estimate to be made as nearly as might be of the expenses of the same and did proceed to have a new bridge erected over said Creek at said location by entering into a contract with Elder & Evans for the building of said Bridge for the sum of TWENTY-EIGHT THOUSAND and TWENTY (\$28,020.00) DOLLARS, and any additional sum that might arise on account of extra work done under the unit prices set forth in the proposal of said Contractors, and that the said bridge is now completed agreeable to the said contract.

Your Petitioners, therefore, pray the Court to appoint three fit persons to inspect said Bridge and the workmanship thereof, agreeable to the Act of Assembly and the supplements thereto, in such case made and provided, and to make report to the next Court of Quarter Sessions to be held in and for the said County.



We, the undersigned members of the Permanent Board of Viewers of Cambria County, appointed by your honorable Court, upon the attached order; to view and inspect a certain concrete bridge over the Blacklick Creek, in the Borough of Vintondale, said county and state; respectfully report:
