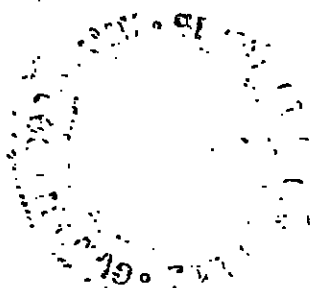

RESOLUTION

Accepting a portion of a certain dedicated Street as a public highway in Lower Yoder Township, Cambria County, Pennsylvania.

Whereas, a petition has been filed with the Board of Supervisors of ~~Lower Yoder~~ Township requesting the acceptance of a portion of a certain dedicated street as a public highway, shown on the Citizens' Coal Company and Charles Griffith, and John Burkhardt Plans of Lots situated in Lower Yoder Township, Cambria County, Pennsylvania, and duly recorded in the office of the Recorder of Deeds in Cambria County, Pennsylvania, in Plot Book Vol. _____ at page _____, Plot Book Vol. 3 at page 53, Plot Book Vol. 2 at page 110, said plans showing location of said street being hereto attached, and

Whereas, it is the desire of the Board of Supervisors of Lower Yoder Township, Cambria County, Pennsylvania, to accept said highway in accordance with the Act of the General Assembly of the Commonwealth of Pennsylvania as amended July 18, 1935, P. L. 1299, Section 1147, providing for the acceptance of dedicated roads, streets, lanes, and alleys heretofore dedicated as public highways.

Therefore, be it resolved by the Board of Supervisors of Lower Yoder Township, Cambria County, Pennsylvania, and it hereby is resolved by the authority of same, that Burkhardt Street, a dedicated highway forty (40) feet in width, beginning at the intersection of said Edgewood Road-an improved highway, thence South 75°-57' East 409.38 feet; thence

South 74°-47' East 601.29 feet, to its intersection with Edwards Hill Road, and improved highway, a dedicated highway forty (40) feet in width, within the Township of Lower Yoder, shall be and the same hereby is accepted as a public highway and as a part of the road system of Lower Yoder Township, subject to the approval and consent of the Court of Quarter Sessions of Cambria County, Pennsylvania.

Adopted by the Board of Supervisors of Lower Yoder Township, Cambria County, Pennsylvania, in regular session assembled this Second day of August, A. D. 1937.
