

AN ORDINANCE LAYING OUT ROADS WHOLLY WITHIN
ADAMS TOWNSHIP, CAMBRIA COUNTY, PENNSYLVANIA.

WHEREAS the Supervisors have decided in the interest of public convenience, to lay out, by Ordinance, sections of roads, same being parts of private roads.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Supervisors of Adams Township, and it is hereby ordained and enacted by authority of same as follows:

SECTION I. That the following described roads thirty three feet wide be and the same are hereby laid out:

Beginning at the intersection of the road leading from Elton to Sidman with Center Street in Salix and extending North 89 degrees 08 minutes East 671.20 feet to Wissinger Avenue.

Beginning at Geistown Avenue in the village of Elton and extending North 31 degrees West 463.60 feet to township road.

Beginning at Pitcairn Avenue in the village of Dunlo and extending North 56 degrees 26 minutes West; thence North 51 degrees 54 minutes West; thence North 40 degrees 09 minutes West; thence North 37 degrees 13 minutes West; thence North 31 degrees 32 minutes West; thence North 27 degrees 16 minutes West; thence North 22 degrees 53 minutes West; thence North 34 degrees 02 minutes West; thence North 45 degrees 30 minutes West a total distance of 786 feet to the Adams Township Building.

Beginning at the intersection of Crown Street and Meadow Street in the village of Sidman and extending South 49 degrees East 312 feet to Main Street.

Beginning at Adams Township School property in village of Sidman and extending South 49 degrees East a distance of 1465 feet to Main Street.

Beginning at an alley in the village of Sidman thence North 41 degrees East a distance of 1100 feet, being known as Meadow Street.

Beginning at Church Street in the village of Sidman; thence North 41 degrees East a distance of 675 feet to Water Street, being known as Grove Street.

A print or survey of the roads hereby laid out is attached hereto and made a part hereof.

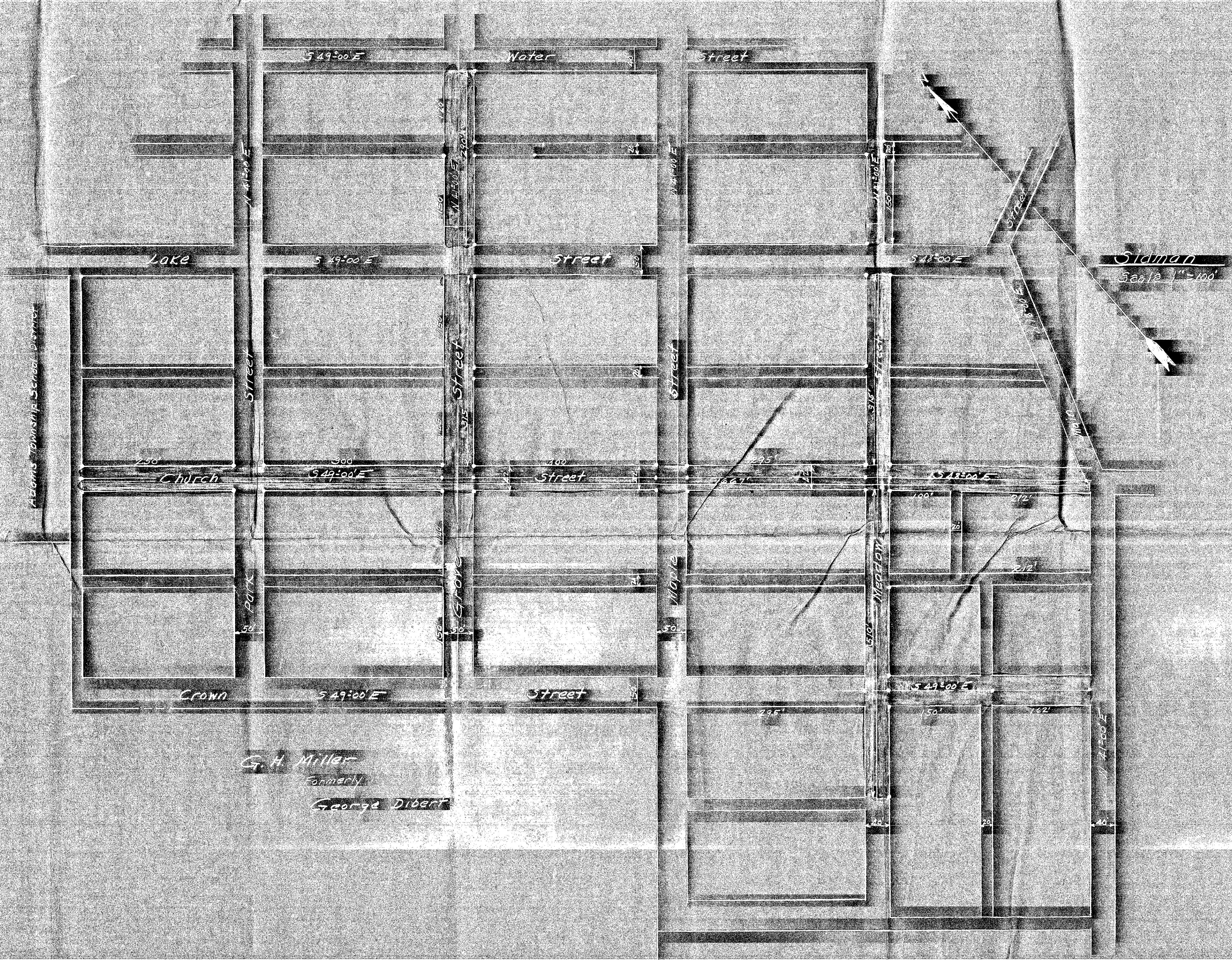
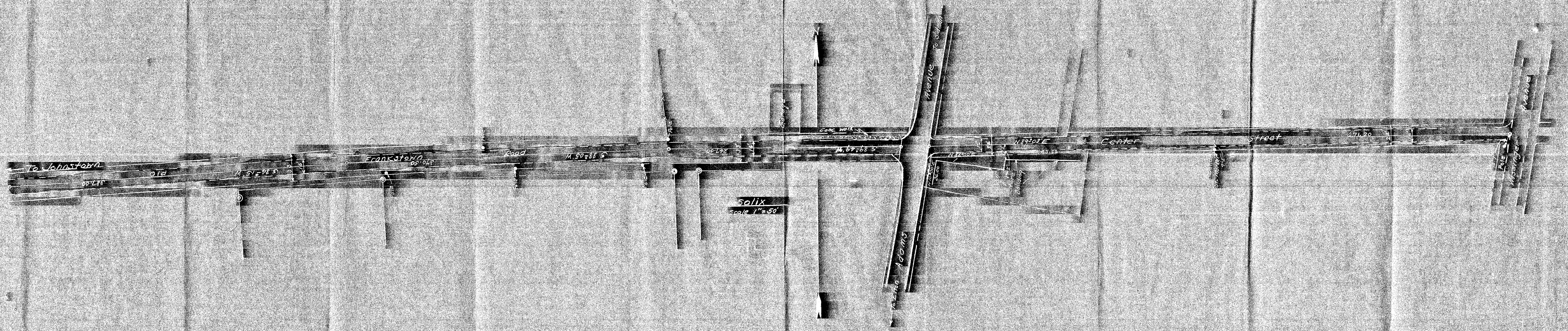
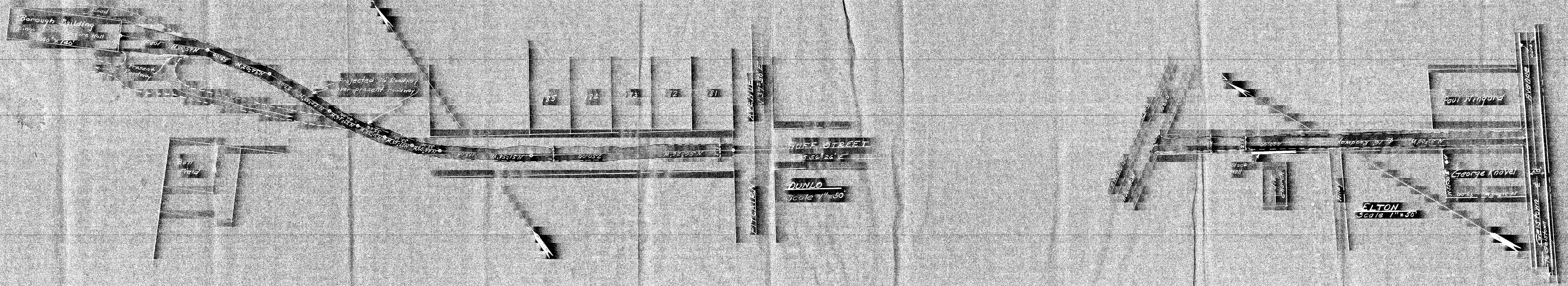
