TO JOSEPH C. WESS, CLERK OF THE COURT OF QUARTER SESSIONS:

The undersigned, the Board of Supervisors of Conemaugh Township, Cambria County, Pennsylvania, do hereby certify that the following Resolution for Conemaugh Township, Cambria County, Pennsylvania, was duly adopted at a regular meeting held the 16th day of August, A. D., 1958, at which the Board unanimously adopted the same.

RESOLUTION
 TOWNSHIP OF CONEMAUGH, CAMBRIA COUNTY, PA.

WHEREAS, the Telford Coal Company, a Pennsylvania Corporation, owner of a tract of land in Conemaugh Township, Pennsylvania, laid out in the year 1928, a plan of lots in said township, a true copy of which plan is attached hereto, marked Exhibit A and made a part hereof: and,

WHEREAS, said plan dedicates certain streets or roads thereon for public use, all of which streets and roads are of a width of not less than forty (40) feet: and,

WHEREAS, subsequent to the laying out of said plan, Telford Coal Company has made numerous conveyances of lots in said plan as noted on the aforesaid Exhibit, all of which conveyances refer to the various streets and roads in said plan: and,

WHEREAS, the Board of Supervisors desires to accept certain portions of the dedicated roads and streets in said plan as part of the public road system for the Township:

NOW, THEREFORE, BE IT RESOLVED:

1 - That the following streets and roads or portions thereof, in the Telford Coal Company Plan be accepted by the Township of Conemaugh and become a part of the public road system of Conemaugh Township:

A. Telford Street, 40 feet in width, beginning at the intersection of Telford Street and Leonard Street and thence continuing South 87° 48' West 1113.40 feet, more or less, to the intersection of Telford Street and Leonard Street, as shown in red on Exhibit A.

B. Skyline Drive, 40 feet in width, beginning at the intersection of Skyline Drive and Telford Street and thence continuing South 8° 19' West 187.07 feet; thence South 13° 46' East 301.26 feet; thence by a curve to the right 131.19 feet, more or less; thence South 30° 58' West 567.38 feet to the intersection of Skyline Drive and Fingerhoot Street, as shown in red on Exhibit A.

C. Fingerhoot Street, 40 feet in width, beginning at the intersection of Fingerhoot Street and Skyline Drive and continuing thence South 87° 48' West 1138.50 feet to the intersection of Fingerhoot Street and Leonard Street, as shown in red on Exhibit A.

D. Leonard Street, 40 feet in width, beginning at the intersection of Leonard Street and Fingerhoot Street and continuing thence North 2° 12' West 280.59 feet, more or less, to the intersection of Leonard Street and Singer Road, as shown in red on Exhibit A.

E. Leonard Street, 40 feet in width, beginning at the intersection of Leonard Street and Telford Street and continuing thence South 9° 19' East 155.83 feet, more or less, to a point; thence South 22° 45' West 185.51 feet, more or less, to the intersection of Leonard Street and Frankstown Road, as shown in red on Exhibit A.

2 - That a certified and attested copy of this Resolution be filed in the Office of the Clerk of Quarter Sessions of Cambria County, Pa.
