RESOLUTION NO. 5865

RESOLUTION GIVING CITY COUNCIL'S  
CONSENT TO THE PENNSYLVANIA DE-  
PARTMENT OF HIGHWAYS TO ADOPT AS  
A STATE PUBLIC HIGHWAY, A CERTAIN  
PART OF SOUTHMONT BOULEVARD.

SECTION 1. BE IT RESOLVED AND IT IS HEREBY RESOLVED  
by the Council of the City of Johnstown that its consent be and is  
hereby given to the Pennsylvania Department of Highways for the said  
Department of Highways to adopt as a part of the State Highway System,  
the following:

"Route 11138 Beginning at a point on Southmont  
Boulevard at the Southmont Borough-City of Johns-  
town line thence in a Southeasterly direction over  
Southmont Boulevard to its intersection with Harsh-  
berger Street (Legislative Route 11007) a distance  
of approximately .30 mile in the City of Johnstown,  
Cambria County."

SECTION 2. BE IT FURTHER RESOLVED that a copy of this  
Resolution shall be filed by the City Clerk with the Clerk of Courts  
of Cambria County, Pennsylvania, and with the Department of Highways  
on or before November 8, 1963.


SECTION 3. All ordinances and resolutions or parts of
