B. IT ENACTED AND OR-
DAINED BY AUTHORITY OF

be opened and established as a
public road. A map showing the

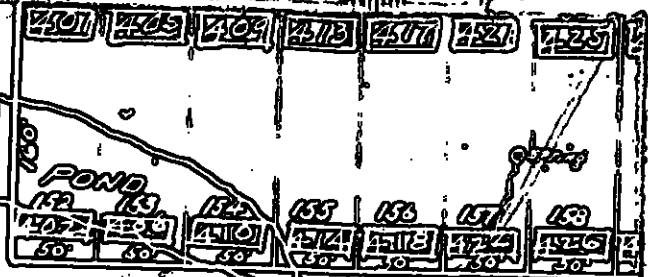
