Ordinance No. 13

AN ORDINANCE LAYING OUT, OPENING AND ADOPTING A PUBLIC
ROAD IN JACKSON TOWNSHIP, CAMBRIA COUNTY, PENNSYLVANIA

The Township of Jackson hereby ordains as follows:

SECTION 1. A road as hereinafter described is hereby opened, laid out and ordained as a public road in Jackson Township, Cambria County, Pennsylvania.

SECTION 2. The center line of the road hereby ordained is described in accordance with a print of a survey by W. J. Battista, Registered Engineer, dated December, 1964, attached hereto and made a part hereof, as follows:

Beginning at a point on the present westerly line of Township Road No. 431 at or near property line of Nathan Taylor and Elmer H. Gillen; thence extending from said point of beginning, South 65° 45' West a distance of 987.8 feet to a point at or near property line of Walter Smith and Leonard Holdsworth; thence by a curve to the left along the center line of a turnaround as shown on the attached print of survey.

SECTION 3. The width of said road from the point of beginning to the line of Walter Smith and Leonard Holdsworth, be and hereby is ordained at forty (40) feet, being twenty (20) feet on each side of the aforesaid center line, and the width of the turnaround be and hereby is ordained at thirty (30) feet in accordance with the attached survey print.

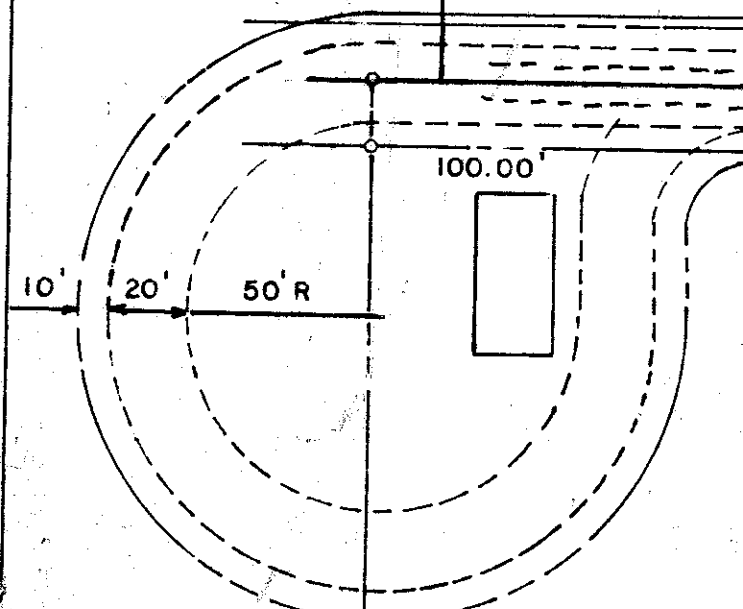
