Ordinance No. 6

AN ORDINANCE LAYING OUT, OPENING AND ADOPTING A PUBLIC  
ROAD IN GALLITZIN TOWNSHIP, CAMBRIA COUNTY, PENNSYLVANIA.

The Township of Gallitzin hereby ordains as follows:

SECTION 1. A road as hereinafter described is hereby opened, laid out and ordained as a public road in Gallitzin Township, Cambria County, Pennsylvania.

SECTION 2. The parcel of land over and upon which said road is laid out is described as follows in accordance with a print of a survey by John C. Henry, Registered Engineer, dated August 14, 1970, and revised September 2, 1970, a copy of which is attached hereto and made a part hereof:

BEGINNING at a point on the easterly right of way line of U. S. Highway Route No. 53 leading from the Borough of Cresson to the Borough of Gallitzin, said point of beginning being approximately 2.1 miles North of the intersection of said U. S. Highway Route No. 53 with U. S. Highway Route No. 22; thence South  $66^{\circ} 37' 12''$  East 327.96 feet to a point on the line of Gallitzin Borough; thence along the Gallitzin Borough line, South  $20^{\circ} 44' 46''$  West 50.05 feet to a point on said Borough line; thence North  $66^{\circ} 37' 12''$  West 330.64 feet to a point on the easterly right of way line of U. S. Highway Route No. 53; thence along the easterly right of way line of U. S. Highway Route No. 53, North  $23^{\circ} 49' 24''$  East 50 feet to a point and place of beginning.

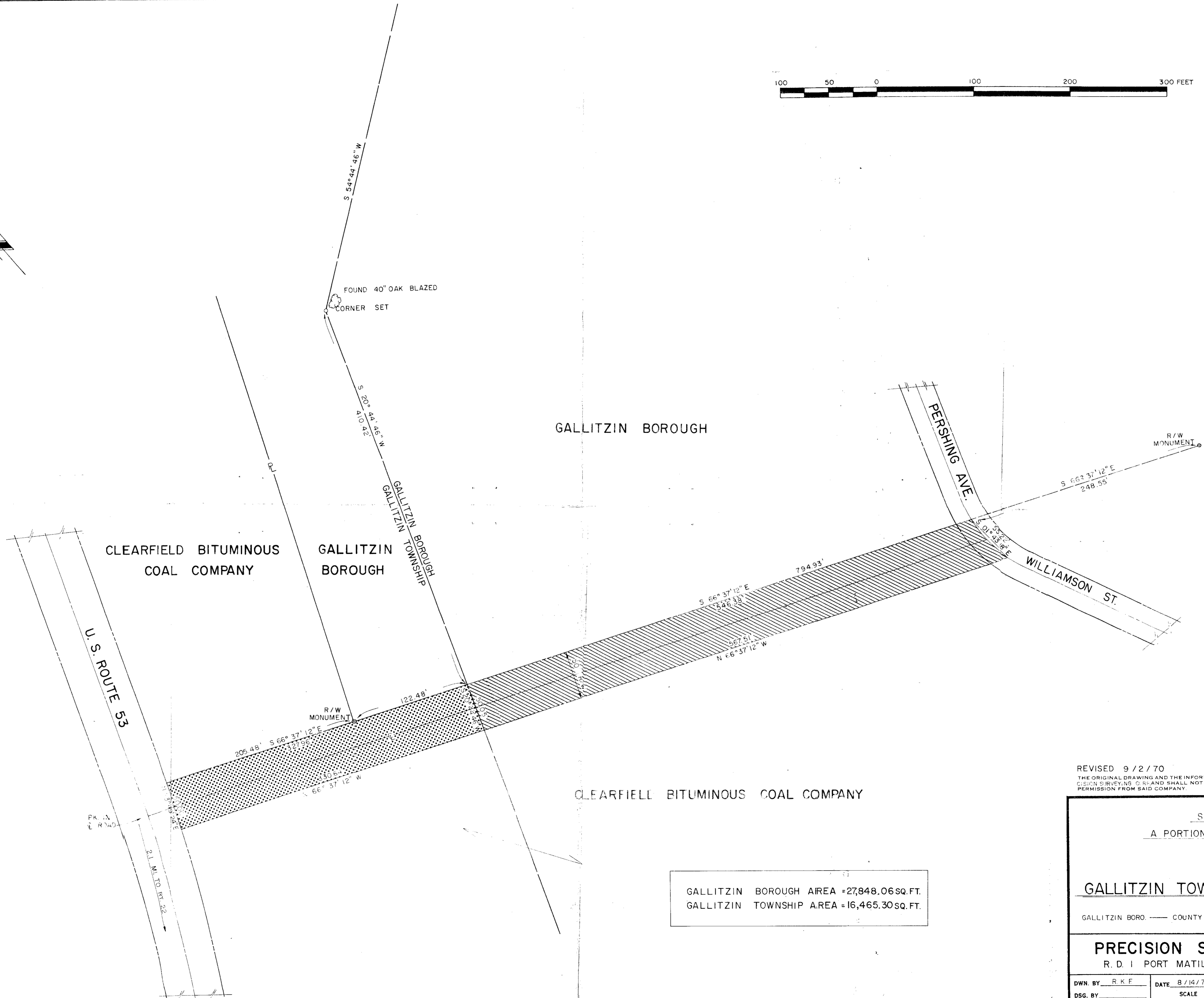
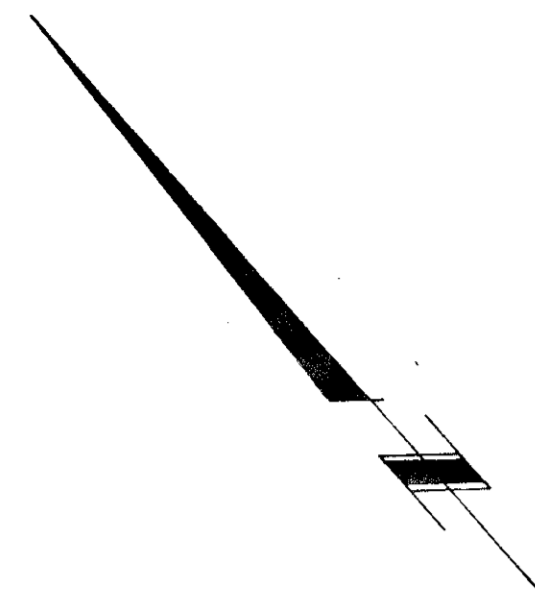
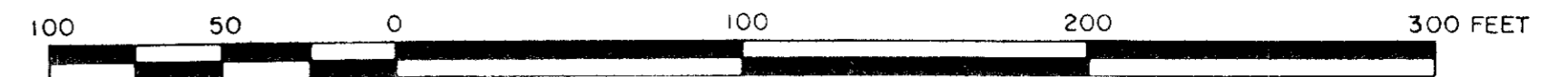
