Ordinance No. 1 of 1978

AN ORDINANCE LAYING OUT, OPENING AND ADOPTING
AS A PUBLIC STREET IN THE BOROUGH OF SUMMERHILL,
CAMBRIA COUNTY, PENNSYLVANIA, A STREET TO BE
DESIGNATED AS HILL STREET.

The Borough of Summerhill hereby ordains as follows:

SECTION 1. That a public street be laid out, opened and ordained in
the Borough of Summerhill, Cambria County, Pennsylvania, on, through and over
the following parcel of land:

BEGINNING at a point on the northerly line of Dibert
Street at the southwesterly corner of Lot No. 11 on the
attached survey print; thence along the northerly line of
Dibert Street North $63^{\circ} 45'$ West 36 feet to the southeast-
erly corner of Lot No. 10; thence along the easterly line
of Lot No. 10 North $26^{\circ} 15'$ East 130 feet to the southerly
line of a 12 foot alley and northeasterly corner of Lot
No. 10; thence along the southerly line of said alley South
 $63^{\circ} 45'$ East 36 feet to the northwesterly corner of Lot
No. 11; thence along the westerly line of Lot No. 11 South
 $26^{\circ} 15'$ West 130 feet to the southwesterly corner of Lot
No. 11 and place of beginning.

SECTION 2. That a print of a survey by John H. Wald, P.E., dated
July 24, 1978, of the street hereby ordained be and hereby is made a part
hereof.

SECTION 3. That the street hereby ordained be and hereby is
designated as Hill Street.

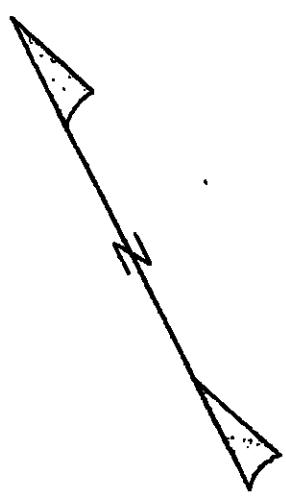
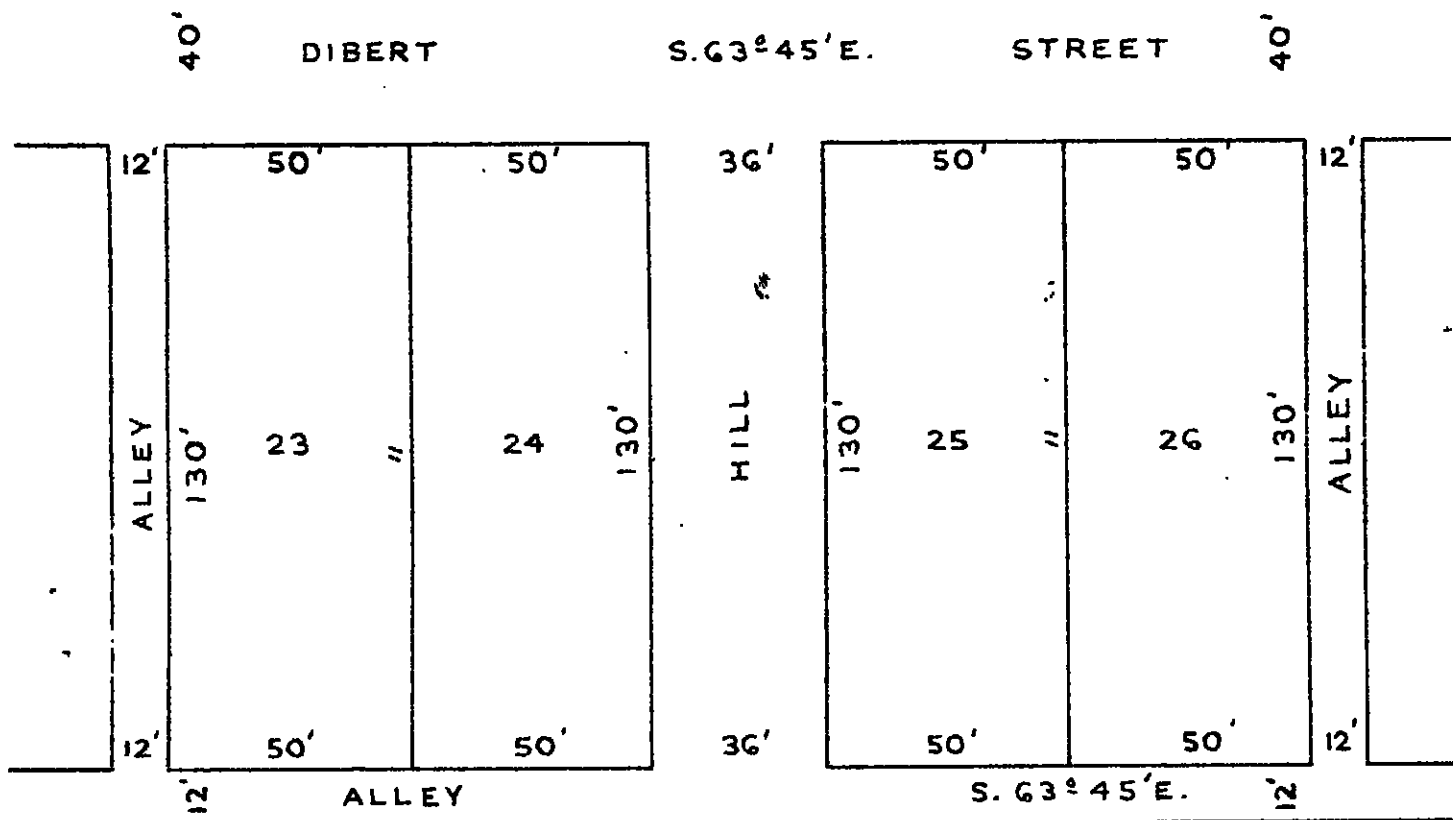
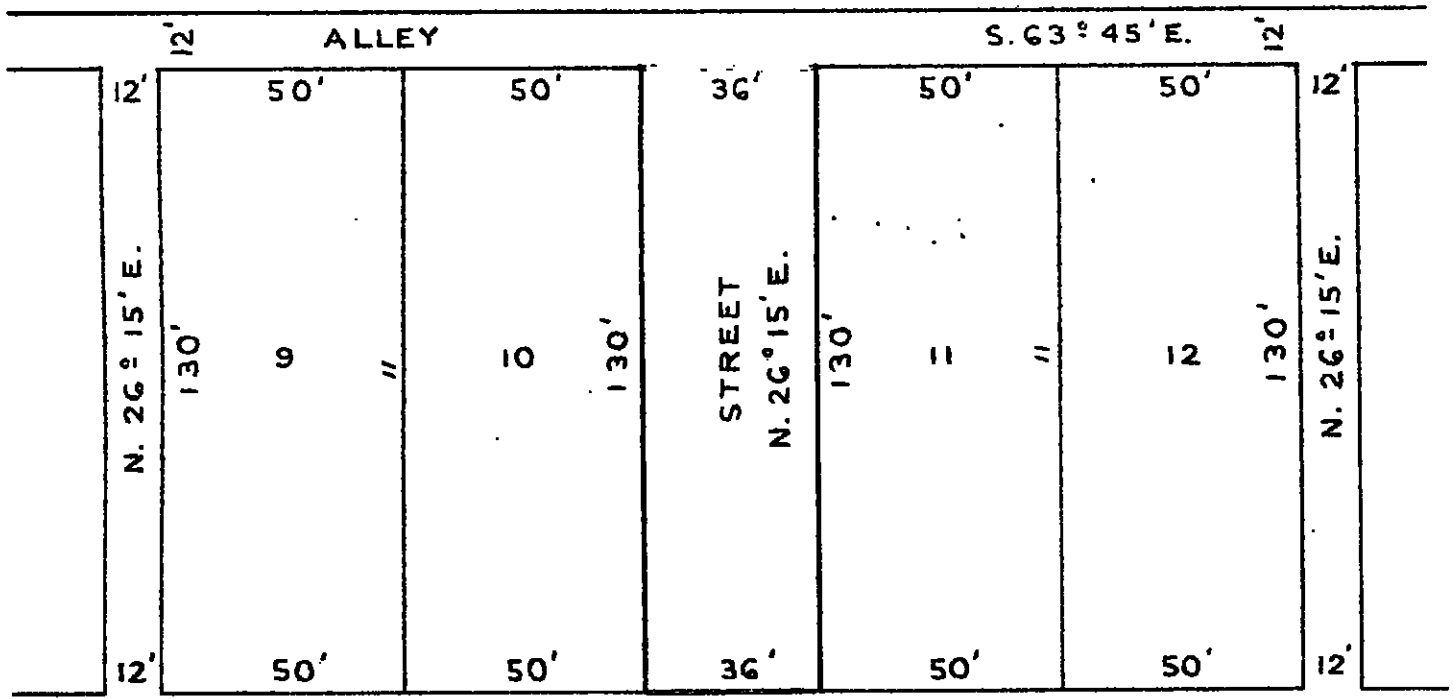
